The Environmental and Consumer Protection Foundation (ECPFO) thru its Authorised Signatory Mr. Rakesh Chandra Agarwal, Executive Chairman hereinafter referred to as 'ECPFO', or the 'Second Party' (which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns) of the Other Part;

'The Institute' and 'The ECPFO' are hereinafter, collectively referred to as the 'Parties' and individually as the 'Party'.

Whereas

 MANGALMAY INSTITUTE OF MANAGEMENT & TECHNOLOGY, Greater Noida (the Institute) is a NAAC accredited Institute, running BBA, B.COM, BCA & B.A.B.ED. programmes

AND

- The Environmental & Consumer Protection Foundation (ECPFO) is working towards implementing Sustainable Development Goals (SDGs) of the United Nation's Development Agenda and towards this end, ECPFO is helping Government of India in implementing Sustainable Development Goals (SDGs) of the United Nations at national level and ECPFO continues to expand its work on sustainable development, climate change, renewable energy with a special focus on solar energy by working together with schools, colleges and Institute to implement and take climate change and environmental sustainability message to teachers, children, and parents through its 'Teachers Training on Climate Change Program" and
- ECPFO also inspires conventional schools to turn into green schools & campuses under its Green School Program and ECPFO already conducting these colleges & Schools all over the country
- ECPFO has also approached MANGALMAY INSTITUTE OF MANAGEMENT & TECHNOLOGY for implementing these programs in the Institute campus and both the Parties are interested to collaborate to implement these two programs in the Institute Campus.

ECPFO has been presently functioning based on 17 SDG's set by the United Nations in 2015 for Global sustainability achievements. We work on Waste Segregation, Water Conservation, Restoration of Lakes, conducting Workshops in Colleges, Institute & NCC Cadets to create awareness about Environmental issues & techniques. ECPFO also provides Clean Air Solutions. The system handles and eliminates air pollution and provides sterilized safe Air Zones by treating Ambient Air Pollution comprising diverse particulate pollutants of Microbial contaminations like Virus & bacteria.

Therefore,

• It is mutually understood and agreed by and between the Parties to collaborate through this MOU, to achieve the objectives and the terms of collaboration mentioned herein below:

Objectives

- To spread awareness in the students, faculty and surrounding community related to the
 environmental issues such as climate change, conservation of natural resources, use of
 renewable energy resources, solid waste management, water conservation and rainwater
 harvesting, tree plantation, Clean Air Solutions and such other issues.
- To help the Institute in implementing "Green Campus Program" in the Institute.
- "Green Campus Program" is a physical campus transformative process to build a
 sustainable campus, by implementing renewable energy solutions through solar panels,
 rainwater harvesting, waste segregation and composting in campus, development of green
 spaces, improving air quality and so on, thus creating a healthier campus for the students.
- To implement "Teachers Training on Climate Change Program" in the Institute so that subsequently, the teachers and educators may spread awareness and create positive change about the issues in other Institute, colleges, and community.
- To develop teaching contents on the environmental issues and make it readily available digitally to the Institute for implementation.
- To undertake seminars, workshops, conclaves, training, meetings, campaigns and conferences in collaborations and partnerships with government and nongovernment agencies on the climatic and environmental issues.
- To undertake any other activities and share programs and resources that will address the sustainability education, climate change and other environmental issues for the betterment of the students, Institute teachers and our country on a larger canvas.

Resolution

• The Institute & ECPFO resolve to jointly implement the following programs of ECPFO in the Institute campus:

Hmal

- Teachers Training on Climate Change Program and o Green Campus Program. o ECPFO, would like to Plant trees, develop medicinal Nursery, conduct workshops to create awareness, Waste Segregation, Provide Clean Air and Recycling of all Waste generated in your Campus.
- After signing this MOU, a detailed action plan will be prepared by ECPFO in coordination with the Institute SPOC person (please see Clause 6) to implement the above Programs.
- The Programs will be implemented within a time frame of one year.
- If Programs could not be implemented within the agreed timeframe of one year due to unexpected events like pandemic, natural disaster or any unforeseen events of force majeure nature, the timeline will be extended by one year by mutual agreement.

Nature

- This MoU is non-exclusive in nature. Parties shall be free to enter into similar MoUs with any other Party during currency or the extended currency of this MOU.
- This MoU is non-binding, non- enforceable and non-financial in nature.
- Institute shall use its own funds and resources for implementing programs under collaboration under this MOU. ECPFO will provide consultancy services for which no fee will be charged. However, reimbursement of conveyance charges shall be done by the Institute.

Term and Termination

- The MoU shall come into force immediately upon its signing by the parties. The MoU will be in force for an initial period of one year. MoU may be extended further for one year on the mutually agreed terms.
- This MoU may be terminated by mutual consent of the parties before the aforesaid term of one (1) year.
- This MoU can be terminated by either of the parties by giving advance notice of one (1) month period without jeopardizing the ongoing collaborative undertakings i.e. to say that the implementation and/or continuance of programmes or project established pursuant to this MoU prior to the effective date of termination shall not be affected by the termination of this MoU.

Force Majeure

The Parties shall not be liable for any failure to perform, any of its obligations under this
MoU if the performance is prevented, hindered, or delayed by a Force Majeure event
(defined below) and in such case its obligations shall be suspended for so long as the
Force Majeure event continues.

- "Force Majeure Event" means an event which is beyond the reasonable control of the Parties concerned, including, without limitation, unavailability of any communication system, sabotage, fire, flood, explosion, acts of God, civil commotion, strikes or industrial action of any kind, riots, insurrection, war or acts of government etc.
- Each party shall promptly inform the other of the existence of a Force Majeure event and shall consult together to find a mutually acceptable solution.

Single Point of Contact (SPOC) Persons

- All the Parties will nominate one person from their Institution to act as a Single Point of Contact (SPOC) for coordinating various programmes, projects and activities, jointly to be undertaken under this MoU.
- The SPOC persons will be responsible for information flow and communication between the Parties.
