- Either Party may disclose the general terms of this Agreement (but not the commercials or the specific details therein) for publicity subject to the condition that the Party so wishing to disclose gets the content to be published, publicized, or disclosed to be approved by the other Party.

### 4. Communication & Acknowledgements:

- Any email or written request to either party must be acknowledged and answered by both parties within 48 Hrs. If there is any failure in 3 such instances, the MoU will lead to termination.

### 5. Termination of MoU:

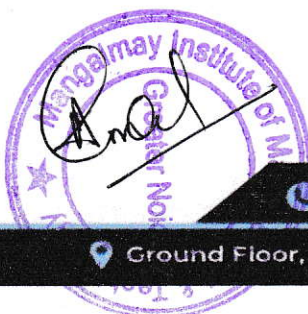
- Any matters deemed contentious from either party shall have to be discussed with respective representatives with a buffer time of 1 week. No response from the opposite party, even after one week shall grant the rights to the first party to issue a notice via email for cancellation of the MoU. Due to any natural calamities, any unforeseen circumstances postponing the Placement drive/Trainings will be honored by both parties. A failed response for one week for the notice shall automatically terminate the MoU on the grounds of irreconcilable differences.
- Termination of the MOU deed will be signed by Both Parties for MOU Termination.

### 6. Limitation of liability:

- Neither party shall be liable to the other party for any indirect, incidental, consequential, or special damages, including but not limited to loss of profits, loss of investment, loss of opportunities, loss of goodwill or reputation.

### 7. Force Majeure:

- Neither party shall be liable to the other for failure or delay in the performance of any of its obligations under this MoU for the time and to the extent such failure or delay is caused due to acts of God, natural disaster, fire, floods, explosions or earthquake, epidemic or quarantine restrictions, pandemic, serious accidents, war, insurrection or riots, strikes, Governmental Act, orders or restrictions, or any other cause beyond the affected parties reasonable control, provided that Sufficient notice of such occurrence or force majeure is communicated to the other party and the affected party shall do everything reasonably practicable to resume performance.



8. Miscellaneous:

- This MoU supersedes all prior understandings, if any, between the parties concerning the subject hereof.
- No amendments to the MOU shall be valid unless executed in writing and signed by both Parties.
- The Institution must follow the rules and guidelines as laid down by the Company. The Operational guidelines are to be strictly followed by the Institution and its associates failing which the MoU shall be terminated, and the Institution or its associates shall not be liable for any refund or support.
- The company and its associates, personnel, and partners are solely permitted to raise any concern thereof to its respective Point of contact and no other person(s) are to be involved unless authorized by the Institution's team. Any due diligence of the concern above mentioned shall be the sole responsibility of the Institution team.
