

WHEREAS:

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

## OBJECTIVES of the COLLABORATION:

- To have **GRAS**tech as a Training Partner to train students of **MIMT** from engineering and non-engineering streams at MIMT campus at Greater Noida.
- To provide 180 Hrs. hands on practical training programs to 250 EWS final year students in various technologies like AI, BPM, BFSI and Soft Skill Training to students of **MIMT**.
- Make the student aware of the latest tools and techniques in order to keep them industry ready at the end of their course.
- To build/improve the confidence level of the student to face the challenges of real time.

## ACTIVITIES & RESPONSIBILITIES OF <sup>M</sup>MIMT:-

- a. College shall introduce this training program with the final year EWS students of engineering courses and non-engineering course.
- b. College shall provide the infrastructure facilities to **GRAS**tech as per requirement for conducting training programs.
- c. College will facilitate in scheduling of batches to conduct the training program.
- d. College will facilitate collection of documents like income certificate, ID card, and any other relevant document as per the need of donor agency.
- e. College will help in placement of candidates through placement drives and share proof of placement with **GRAS**tech.

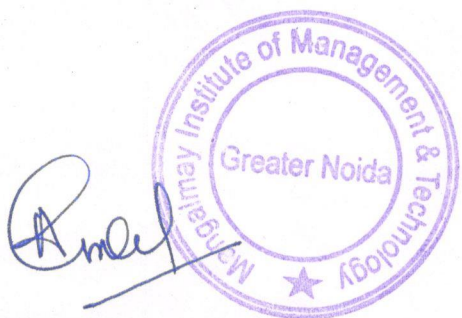
## ACTIVITIES & RESPONSIBILITIES OF **GRAS**tech:

- **GRAS**tech will offer free programs to 250 EWS candidates under CSR depending on the projects allocation from the donor. 60% of the participants would be females.
- **GRAS**tech will deploy qualified trainers at the college premises to deliver the training. 120 hrs of domain training and 60hrs. of soft skills training.
- **GRAS**tech will collect all necessary documents from candidates in consultation with **MIMT** staff.
- **GRAS**tech will facilitate assessment, certification and placement of candidates trained under this scheme.

## TERM OF THE AGREEMENT:

This agreement shall be initially valid for a period of **3 year** commencing from the date of the agreement that is (1<sup>st</sup> Sep 2024) . The term may be extended for further period by mutual consent in writing by the parties.

The parties hereto have set & subscribed their respective hands and seal on the day, month & year herein above mentioned.



**AMENDMENT:**


Any addition, deletion and/or alternation to this agreement may be effected with a written agreement by both parties to this agreement by mutual consent concerning the amendments. A document containing the additions, deletions and/or alternations, signed by both parties hereto shall form an annexure to and be deemed to be a part of this agreement.

Any divergence or difference derived from the interpretation or application of the MOU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of **Delhi**.




