- To enhance social responsibility and awareness among students while benefiting the larger community.


3. Scope of Activities

o Handle logistics, safety protocols, and other organizational aspects.





4. Duration of the MoU

This agreement will be effective from Date 05/02/2025 to 04/02/2028 unless extended by mutual consent of both parties.

- Regular reports and updates will be shared between the college and the Vedika Founation to monitor progress.

8. Termination of the Agreement

Either party may terminate this MoU with written notice, giving specific notice period of 30 days. In case of termination, both parties will complete any ongoing projects unless mutually agreed otherwise.


